Carp France Terms and Conditions

- All bookings will be confirmed in writing upon receipt of a completed booking form and a cleared payment of the deposit which is non-refundable
- The balance is due no less than 10 weeks before the commencement of your holiday. If payment is not made by the due date, we will consider this as a cancellation
- We reserve the right to withhold all or part of the security deposit if breakages or damages are discovered and if the accommodation and lake have not been left in a clean state. This does not limit the customer's liability to the us. The customer shall report without delay any broken or missing items, defects or breakdowns at the start of their holiday and any that occur during their holiday
- The number of people will be fixed at the time of booking. Any additions can only be made with permission of the owner before the start of the holiday
- Customers must be considerate and not act in a way that would cause disturbance other people or our neighbours
- To avoid disappointment, equipment hire, bait, and food packages, must be agreed before arrival and paid for on arrival (in € cash)
- Please ensure you have adequate holiday, health and accident insurance as we accept no responsibility for accident, injury or delays and cancellations unless it is a result of our direct action.
- Any infringement of the rules will result in the termination of your holiday without refund

Carp France Rules

We want you to enjoy your holiday at our fishery but in order to protect our fish and our property we have put in place some essential rules:

- Maximum of three fishing rods per angler and no rods to be left unattended when your line is in the water
- Maximum one hook per rig
- All bait fish must be caught at fishery (if fresh water fish baits)
- No nuts or shelf-life boilies, lead core or barbed hooks (barbless hooks only) and no braided main lines, snag leaders or shock leaders
- Rig tubing must be use no less than 600mm when ledgering
- Cradles and weigh lings are provided – please use these and not your own
- Carp care antiseptic gel must be used to treat hook wounds after each catch (available to buy if needed)
- Ensure all hooks with boilies attached are at least 4ft off the ground if unattended to avoid injury to wildlife and pets



Carp France Rules (continued)

- Ensure your landing net is always within reach
- All fish must be released and returned to the water as quickly as possible with the utmost care (make sure your camera works in the dark)
- Always use an unhooking mat and never leave a fish unattended
- Make sure you always have a bucket of lake water to hand and everything ready for when you catch
- No standing for photos and ensure the carp is held safely and securely. Any catfish over 70lbs must be held by 2 anglers for photos
- Please report any damaged fish to Nigel or Jo before putting back in the lake
- Bait boats must be used with great care not to drive into snags
- Dispose of all litter including fishing line, cigarette ends and tea bags – do not leave rubbish in your swim. Please use the ashtray provided at the chalet rather than the ground for cigarette ends
- Use the toilet in the chalet, especially for number twos and please do not pee against the bivvys Please remember rowing boats can be dangerous – it is your responsibility to provide your own life jacket
- No swimming in the lakes and if you have children under the age of 16 with you must accompany them at all times
- Swimming pools will be available to use from June to September but children must be observed at all times
- Please report any breakages so that we can sort them as soon as possible
- We will not tolerate **any intoxicated, aggressive, excessively loud or unsafe** behaviour
- We reserve the right to terminate your stay without refund if any of the above rules are not followed
